

COVID-19 SCHOOL NOTIFICATION LETTER

Dear Moscrop Secondary School Community,

We are writing to let you know that someone with COVID-19 was at Moscrop Secondary School, Burnaby on:

March 10, 11, & 12, 2021

This is a general notification and does not mean you or your family have been exposed to COVID-19. The person involved has been isolated; as such, there is no chance of direct exposure at this time.

A Public Health risk assessment is underway and you may receive further instructions.

- Staff or students who are determined to have been in close contact with the case will receive a phone call or letter from Public Health with instructions to **self-isolate**.
- Some staff or students may be asked to **self-monitor** for symptoms of COVID-19.

Case and contact management for an individual case is typically completed within 48 hours of Public Health receiving notice of a confirmed case of COVID-19. Unless you are directed otherwise, please continue to attend school and use the Daily Health Check supplied by your school to monitor for signs of COVID-19. Please also remember to follow current public health orders to limit spread of COVID-19 in the community and schools.

Public Health staff works closely with the school and school district throughout the case and contact management process. Please note, only Public Health can determine who is a close contact.

For privacy reasons, we cannot give any specific details about the exposure except for what is in this letter.

How is COVID-19 transmitted?

This virus is spread by liquid droplets in the air. These droplets get into the air when an infected person coughs, sneezes, talks, or sings. Droplets can come from their nose, mouth or throat. These droplets can land on a person if you are close by. The virus can also spread by touch. If droplets are left on objects and surfaces, a person could become infected by touching these objects or surfaces. The virus enters the through the eyes, nose, or throat.

What if staff or students develop or already have symptoms of COVID-19 - even mild ones?

- The person should be immediately isolated and tested for COVID-19. A list of testing locations can be found at <u>fraserhealth.ca/COVID19testing</u>. <u>Book an</u> <u>appointment online</u> or call 8-1-1 for help.
- The person should remain isolated while waiting for results.
- If positive for COVID-19, they must continue to selfisolate and complete the <u>online Case and Contacts</u> <u>form</u>.
- Follow the directions given by the testing location on how long to self-isolate.
